### **President's Report:**

### Treasurer's Report:

- Club balance: \$87,459.59

- o \$40,000 has been moved into a high yield savings account
- Student Grant Fund (\$6000 spent down at Kenwood): \$279.05 remaining

### **Committee Reports:**

- Kenwood [reported by Val]:
  - a. Initial estimates net profit down from last year
  - b. First time we made a 3k less than the 10k
    - i. Saturation point ~640 runners for the 3k
      - 1. Typically around 500ish
  - c. Pancake breakfast
    - i. Saved \$7 by registering online, only \$3 tacked onto the registration
      - 1. We knew exactly how many tickets were bought
  - d. Toilets could not be found as they were moved twice
    - i. They moved them to the park
    - ii. We need to be out there next year to make sure they know where the toilets are going
  - e. Additional cost to t-shirts & photography may lead to a lower net profit
    - i. Photography was an investment into photo sharing, etc.
    - ii. All costs went up
  - f. Participation was up by ~100 (at \$5 more per race as well)
    - i. Normally a 15-20% no show rate; only 65 no shows (unbelievable low)
  - g. Beer garden for next year
    - i. Will need to get on that asap if it is going to happen
    - ii. All beer is already donated, just need volunteers to run the beer tent
    - iii. Just need to finalize insurance
  - h. Helpful for next year leave the 10k banner up until after the kids race
    - i. This will leave a marker to start the kids race
  - i. EMT / Medical personnel
    - i. Need better marking for next year; likely have a first aid tent or flag
  - j. Club needs to decide on a breaking point of what is the absolute least we would need
- 2) Cross Country [Stephen Starkweather]

- a. Make sure to sign the waiver
- b. 1st race is August 17th in Santa Cruz
- 3) Grand Prix [Jerry]
  - a. Scandera family will be taking over
- 4) Student Grants
  - a. Next year to give the money out after the 3k (but waited for kid run to be done)
  - b. In January, the letters are sent out to the coaches in Sonoma County with the application
  - c. Next year we could have representatives at each school's awards night

  - b. Many members seemed to be behind this; not any nay sayers
